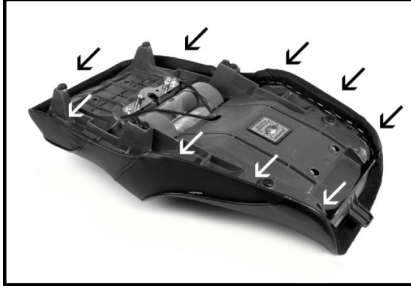


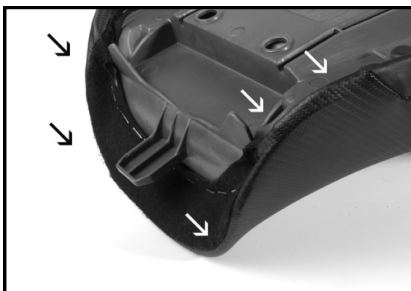
ATTENTION!

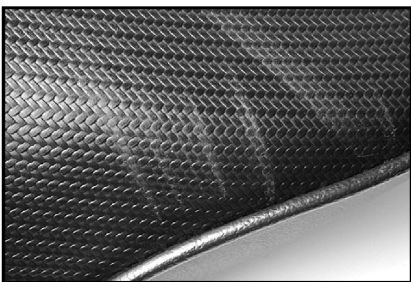


Seat vinyl that wraps around the seat pan edges may be damaged easily by hitting hard or rough surfaces.

When handling your new seat or accessory, remember to place the item foam-side down and bottom edges up on a smooth, padded surface.



All edges are susceptible to damage so take extra care in these areas.



Shoe and boot scuffing may permanently change the vinyl surface and in most cases cannot be repaired.

SEAT EDGE WARNING

High quality and durable materials are used in the construction of your seat and its covering. These materials will last for many years under normal use and care. However, great care should be taken when installing it, removing or storing it. The seat edges are particularly susceptible to damage if not handled properly.

Easily prevent tears, cuts, scratches, nicks, scuffs, or other permanent damage to the seat cover by following these simple guidelines.

Upholstered Products Handling recommendations:

- ✓ ALWAYS gently place the seat foam-side down, (bottom edges up) on a soft, padded surface. For other upholstered products always place on a soft surface.
- ✓ ALWAYS take extra care to ensure that the edges of the seat do not hit hard surfaces or pinch against motorcycle framework during installation.
- ⊘ NEVER drop or toss the seat or accessory on the floor, table, or other hard surfaces.
- ⊘ NEVER slide the seat or accessory across pavement or other hard, rough surfaces.

Storage suggestions:

- ✓ ALWAYS protect your investment by putting the seat or accessory in a well protected area or use the original box.
- ✓ ALWAYS gently place the seat foam-side down, (bottom edges up) on a smooth, padded surface.
- ⊘ NEVER stack anything on top of the seat or upholstered accessory.

CarbonFX / DTX AND OTHER MATERIAL SURFACES

Many upholstery materials - including CarbonFX and DTX - are subject to shoe and boot scuffing when getting on or off the bike. Extra care should be taken to avoid this type of damage.

Helpful Tip: Utilizing the left side foot peg when boarding the motorcycle can be a great way to gain extra clearance, preventing scuffing of seats, luggage and backrests.

Warning! Always be sure the motorcycle is on a level surface and carefully test this method with your particular motorcycle before adopting it.



GENERAL MAINTENANCE

World Sport Performance seats and accessories are upholstered in an outdoor quality marine grade vinyl. No special maintenance is required. Gently wash the seat with mild soap (or bike wash soap) and water solution. To remove stubborn dirt and grime, use mild automotive vinyl surface cleaners and a soft cloth or brush and gently scrub surfaces.

BREAK-IN PERIOD

Most World Sport Seat customers find that our seats do not require a break-in period. Sargent recognizes that each rider's comfort level is different and that the new shape and support of the World Sport Seat is something that may require an adjustment period. We recommend riding as often as possible to realize the benefits of your new purchase. We think that you'll find that you've made a great investment in riding comfort.

LIMITED WARRANTY

Sargent Cycle Products, North America (Sargent), warrants to the original consumer purchaser that this product sold and manufactured by Sargent shall be free from defects in workmanship and materials for the period of one (1) year from the date of purchase. Within this period, Sargent will, at its sole option, repair or replace any component that fails during normal use. Such repairs or replacement will be at no charge to the consumer provided that the consumer shall be responsible for shipping or transportation costs to the service facility.
